**Effective Date** 22 Oct 2020

**Description** On 22 October 2020, Refinitiv released a new version of the FX Trading GUI. This is version 7.7 and contains key new features, enhancements and bug fixes and rebranded user interface. It is mandatory that all FXT users have upgraded to FXT 7.7 or above by 31 July 2021.

**Connectivity FQDNs:**

FQDNs that previously pointed to Thomson Reuters domains are being updated to point to Refinitiv Domains. Client's network must support Refinitiv and Thomson Reuters domains to allow FXT 7.7 to be used. See the FXT 7.7 Release Notes for details.

**Refinitiv rebranding:**

As we transition our brand, products and technology from Thomson Reuters to Refinitiv you will now see changes. From FXT 7.6, the software and installation program has been updated with Refinitiv branding. Only users who install the latest version of FXT will see the fully rebranded GUI. Some aspects of the branding such as login and landing pages maybe updated later.

**Change to FXT Updater process:**

When using the FXT Updater to upgrade from 7.5 or below extra steps are required. See the attached FXT Updater Quick Start Guide. The process for downloading the executable from MyRefinitiv and installing FXT remains unchanged.

**Aggregator (Pricestream):**

Added trade support for OffVenue Non-Deliverable Futures (NDFs) across 12 currency pairs for all standard tenors and broken dates. Please contact your Refinitiv Relationship Manager to be permissioned.

**Refinitiv Aggregator:**

The Refinitiv FX Aggregator is launched by clicking the Refinitiv Aggregator button in the navigation bar. Refinitiv Aggregator brings access to Refinitiv venues and leading sources of liquidity, such as CBOE FX and Euronext FX, on one hosted platform. Please contact your Refinitiv Relationship Manager to be permissioned.
