


## ITALY: Mergers & Acquisitions, Full Year 2020

### Italian involvement M&A increases 37% YoY despite 23% decline in the number of deals; Half of merger activity recorded in final quarter

- Announced M&A with any **Italian involvement** totalled US\$75.6 billion during 2020, 37% more than the value recorded during 2019 despite a 23% decline in the number of deals. Over half of merger activity was recorded during the final three months of the year, with deals announced during the fourth quarter of 2020 reaching US\$38.4 billion, the highest quarterly total since Q1 2018.
- 1240 deals with Italian involvement were announced during 2020, the lowest number since 2015.
- The largest deal of 2020 was Nexi's US\$7.4 billion bid for Danish payments firm Nets in November, just weeks after it agreed to merge with SIA.
- Deals worth a combined US\$60.6 billion involved an Italian target, 92% more than the value recorded during 2019 and a five-year high. Domestic activity reached a thirteen-year high of US\$28.9 billion, while inbound deals tripled to reach US\$31.7 billion.
- Italian outbound M&A activity totalled US\$12.8 billion during 2020, 34% less than the value recorded during 2019 and the lowest annual total in three years.
- Advising on each of the largest six deals announced during 2020, Goldman Sachs tops the 2020 financial advisor ranking for M&A with any Italian involvement.


