



SPAIN: Mergers & Acquisitions, First Half 2021


Spanish involvement M&A reaches three-year high of US\$50.7 bln, driven by telecoms deals; Inbound M&A increases 61%; Outbound M&A at 11-year high


- M&A with any Spanish involvement reached US\$50.7 billion during the first six months of 2021, up 54% from the same period in 2020 and the highest first half total since 2018. Three mega deals, valued at US\$5 billion or more, were recorded, compared to two during the same period in 2020. The largest was American Tower's acquisition of the telecom tower unit Telxius from Telefonica and KKR.
- A total of 689 deals with Spanish involvement were recorded during the first half of 2021, 51% more than the same period in 2020.
- Deals involving telecoms targets accounted for 45% of Spanish involvement M&A during the first half of 2021. The next most targeted sector was energy & power, which accounted for 23% of deals by value.
- Deals worth US\$33.3 billion involved a Spanish target 105% more than the value recorded during the first half of 2020. Inbound M&A, involving a foreign buyer increased 61% to US\$23.9 billion, while domestic deals reached a five-year high of US\$9.3 billion.
- With deals including Cellnex's US\$6.3 billion bid for telecoms tower company Hivory, Spanish outbound M&A totalled US\$12.8 billion during the first six months of 2021, more than triple the value recorded during the same period in 2020 and marking the highest first half year total since 2010. A total of 98 Spanish outbound M&A deals were announced during this period, up 51% from the previous year.




Announced Spanish Inbound M&A by Acquiror Nation, 1H 2021
