2. Key facts

- Identify positive or negative score changes for the week, stocks with the best or worst ratings or stocks with
 positive scores and high dividend yields (bullish high yielders) from the Idea Generation menu
- Download PDF reports to save or share with clients
- Easily export Idea Generation data to Excel® for further review

3. Top tips on how to use the app

- To access the app, type SRPLUS in the Workspace search box and select the entry from the autosuggest options
- Enter a RIC symbol or company name in the Workspace search box or, to restrict the results to equities only, use the search box in the app

- Click on any blue RIC symbol in the peer sections or reports to view the data for that company
- Click on any blue field heading in the Stock Analysis reports to view a definition for the field
- View and download PDF reports. On the Stock Ratings Summary report, the drop-down list next to the PDF icon includes additional reports that are currently only available in PDF format. The Detailed Stock Report provides the most thorough analysis of each component score in Stock Reports Plus. The last two pages of the PDF reports provide tips that describe the Stock Reports Plus ratings methodology and calculations



 In the Idea Generation reports, hover over a field heading and click on the question mark icon that appears to view a definition of the field. Click on a field heading to sort the data in ascending order and click on the field heading again to sort the data in descending order
